SUBJECT : CALL FOR SUBMISSION OF APPLICATION TO BECOME A DELIVERING HIGHER EDUCATION INSTITUTION (DHEI) FOR THE MODIFIED SECOND GENERATION GENERAL EDUCATION (GE) FACULTY TRAINING FOR THE TEACHING OF THE NEW GE CORE COURSES

The Commission on Higher Education hereby announces the call for the submission of application to become a delivering higher education institution (DHEI) for the Modified Second Generation General Education (GE) Faculty Training for the Teaching of the New GE Core Courses.

The CHED conducted the Trainers Training and the Second Generation Training under the CHED Faculty Training for the Teaching of the New GE Core Courses during the last quarter of 2016 and the early quarter of 2017 and was able to train about 900 faculty members as Trainers and 2,884 faculty members or a total of 3,784 GE faculty.

To further assist the HEIs in the teaching of the new GE by training more GE faculty members, the Commission en banc (CEB) approved to implement the Modified Second Generation GE Faculty Training for the Teaching of the New GE Core Courses. The implementing guidelines was developed to allow greater flexibility in the implementation in terms of qualifications of faculty participants and schedule of the trainings. Any tertiary faculty member who is teaching or will teach a GE course will be qualified as a participant as long as he/she is endorsed by the head of the institution, and will show evidence that he/she will render the required return service upon completion of the training. Also, the schedule of the conduct of trainings will be set by the DHEI based on their availability. Attached is the **CHED Memorandum Order No. 69, series of 2017, "Implementing Guidelines for the Modified CHED Second Generation GE Faculty Training for the Teaching of the New General Education Core Courses"**, for your guidance.

The Modified Second Generation GE Faculty Training shall be organized and conducted by DHEIs recognized by CHED. To allow flexibility and appropriate delivery modes, a DHEI may adopt any one of the models listed in the CMO. Models other than those listed therein shall require prior approval by CHED. The HEI shall submit to CHED its application to become a DHEI along with its request for funding to implement the training. The application/proposal for fund support shall be accompanied by a work and financial plan for the training, indicating the delivery mode and projected number of participants per course to be offered.

The following shall be the deadlines for filing applications:


Batch 1: September 15, 2017

Batch 2: October 15, 2017

To allow time in the processing of the release of 2017 funds, the above deadlines shall be strictly observed. The training schedule for the Modified Second Generation GE Faculty Training shall be any time from October 1, 2017 to July 31, 2018 and the training shall be completed within this period.

Interested HEIs must accomplish the attached application form and submit to the Director IV, Office of Programs and Standards Development, 3rd Floor, HEDC Building, C.P.
